ADMINISTRATIVE ORDER

AND NOW, this 16<sup>th</sup> day of March, 2020, after consultation with the Cumberland County District Attorney, Court Administrator, Sheriff, and Public Defender, and to better allow the common pleas judges, magisterial district judges and hearing officers of the 9<sup>th</sup> Judicial District to continue performing the Judicial District's essential functions for the duration of Cumberland County's temporary policy and guidelines addressing the coronavirus, it is hereby ORDERED and DECREED as follows:

1. All judges, magisterial district judges, and hearing officers, when reasonably possible, shall do the following:
  - a. utilize, and encourage litigants to utilize, to the fullest extent available, telephonic, video/audio devices and other advanced communication technology to reduce personal appearances for hearings, trials, meetings, conferences, and similar proceedings or gatherings;
  - b. stagger court appearance times to reduce crowding; and
  - c. limit meetings, conferences and other gatherings to essential participants and arrange seating to avoid unnecessary close personal contact;
  - d. liberally grant requests for continuances.

2. Other than the modifications described above, the judges and hearing officers shall schedule and conduct hearings and trials in essentially the same manner they were scheduled and conducted before the discovery of coronavirus.
3. The Cumberland County sheriff deputies and Cumberland County constables are hereby authorized and directed to decline transportation of prisoners from any prison/jail despite a valid transportation order if, using his or her reasonable discretion, the prisoner to be transported appears to be sick or may have recently (within the last 14 days) been in contact with someone who may be positive for coronavirus. Any sheriff deputy or constable declining transportation on this basis shall immediately contact the appropriate judge/hearing officer involved in the subject case.
4. This Administrative Order is effective immediately.

**ADMINISTRATIVE ORDER**

AND NOW, this 16<sup>th</sup> day of March, 2020, it is hereby ORDERED, ADJUDGED, and DECREED that public access to judicial facilities in the 9<sup>th</sup> Judicial District shall be limited as follows, effective immediately:

1. Court and County employees, officials, and people with badge keycard credentials:
2. Attorneys, litigants, witnesses, victims, and participants in judicial proceedings before the Court of Common Pleas or a magisterial district court (this does not include friends or family members of the above);
3. Individuals with a *bona fide* business need before a Court or Court-related office;
4. Attorneys, litigants, or their representatives filing papers or pleadings, or making monetary payments, with the offices of the Clerk of Courts, Prothonotary, Recorder of Deeds, or Register of Wills (although they are encouraged to do so electronically whenever possible); and
5. Members of the media.

It is further ORDERED that the Sheriff of Cumberland County, or his designee, is authorized to enforce this ORDER and bar individuals from the premises of any judicial facility.
